

Privacy Statement FritsJurgens BV

With this Privacy Statement, FritsJurgens BV, having its office at (9621TK) Slochteren, Korenmolendreef 11, with chamber of commerce number: 0113280 (hereinafter: "FritsJurgens"), explains which personal data it collects and processes and for which purposes, and what its cookie policy is.

General information

FritsJurgens respects the privacy of all the visitors of its website www.fritsjurgens.com, its (potential) clients and other (potential) relations of FritsJurgens. Your personal data will not be sold or traded, nor shared with organisations or individuals that are not related to the services of FritsJurgens in any way. Personal data
